COMPANY PROFILE

Tongkah Harbour Public Company Limited was established by Captain Edward Thomas Miles, an Australian businessman, in 1906 during the reign of King Chulalongkorn (Rama V) to operate a “mining business.”. The company had engaged in tin mining operations in Phuket and was the first in Thailand and among the first in the world to develop tin dredger technology, which had been used for tin mining in the Phuket Bay for seven decades.

BUSINESS EXPANSION

The Company expanded its business to start gold tunnel mining operations in 1984. It undertook a gold tunnel mining at Ban Tohmoh in Narathiwat Province and subsequently gold mining using a flotation technique in Loei Province.

In 1990, the Company tapped into a “property development business” with a focus on condominiums in Bangkok and built the “Tongkah Tower,” which is known as the “True Tower” today. In 2013, the Company expanded its property development business to encompass residential and commercial buildings.



GROWING STRONGER

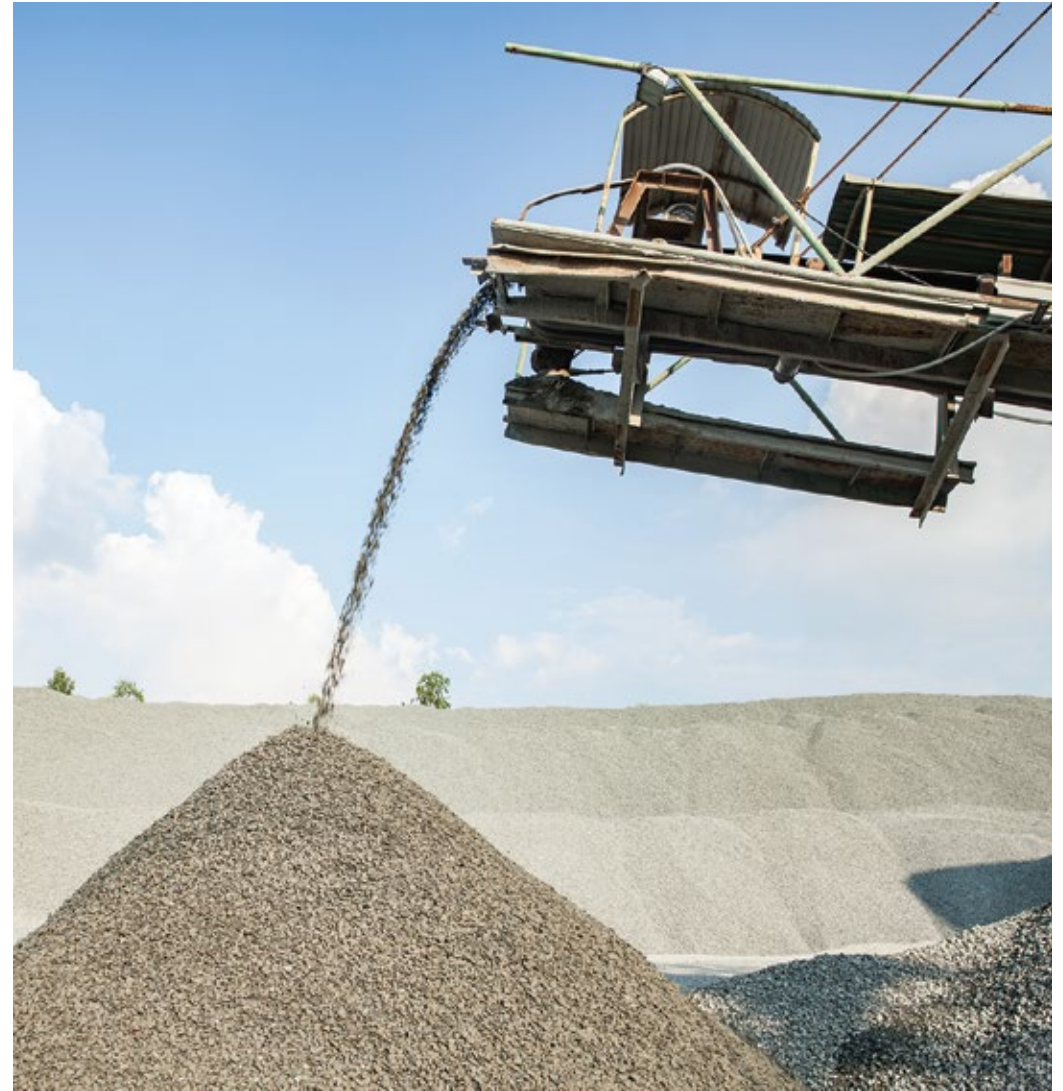

Quarry

In 1995, the Company started andesite mining operations in Kaeng Khoi District, Saraburi Province to produce high quality railroad ballast and construction aggregate.



Tin Mine

In 2016, to expand its business internationally and diversify investment risk, the company signed a contract to operate tin mining for a company in Myanmar. The tin mining operations began in Myanmar in the first quarter of 2017.



Renewable Energy

In 2017, to diversify investment risk, generate regular income, and increase profit, the Company started a “renewable energy business.” The renewable energy business is secure and can generate income in the long run because energy is a basic necessity that is essential to human life and business operations

and the demand for energy will continue to increase. Additionally, the company has business partners who are knowledgeable and also interested in investing in this business.

The company plans to invest in the energy business in both Thailand and CLMV countries and has started a joint venture in a solar energy project to build the first 5MW solar farm for Poonsuk Agricultural Cooperative in Chumphon Province. The farm started to supply electricity in 2018.

With its 111 years of experience in mining, Tongkah Harbour Public Company Limited is one of the oldest fully-integrated mining operators in Southeast Asia, with lengthy experience in property development business and vision in renewable energy for the future.
